

# School District and Kansas City Reach Agreement on Winchester TIF Dr. Allan Markley, Superintendent Raytown Quality Schools

The Raytown School District and the City of Kansas City with Mayor Sly James have reached an agreement on the Winchester TIF. Neighborhood projects at a cost of approximately 3.5 million, including street widening, curbs, and sewer upgrades will be completed. Additionally, with the ending of the TIF, approximately \$3.8 million will be paid to the Raytown School District from the remaining monies housed in a Special Allocation Fund.

"We are pleased to have come to a consensus that protects not only Raytown School District patrons' tax dollars, but also those of other taxing entities with the ending of this TIF," Dr. Allan Markley said.


### ADVANCED EYECARE in RAYTOWN ANNOUNCES GRAND RE-OPENING - Feb. 5 2-5pm

# MARCH MEMBERSHIP LUNCHEON

**MoDOT** staff will be presenting on a **350 Highway Study** currently in progress. The project builds upon earlier studies and looks at the economic impacts of converting a four lane divided highway (Sterling to Maple-separate EB and WB roadbeds with independent alignments) to a combined six lane divided median facility. Included with the roadway improvements is the study of re-assembling of parcels into developable frontage, review of current access and proposed access management improvements, and a return on investment study to determine if the expense of improving 350 Highway will increase economic development within the corridor.
