



# 350 Highway Construction Begins 09/14/2020

#### **RAYTOWN BUSINESSES NEED YOUR SUPOPRT DURING 350 HWY CONSTRUCTION**

On September 14, 2020, the City of Raytown and Missouri Department of Transportation (MoDOT) will kick-off the multi-phase construction of intersection safety improvements at 350 Highway and Raytown Road, expansion of a pedestrian bike and walking trail along eastbound 350 Highway trail, eliminate 75<sup>th</sup> Street access across Raytown Road and new sidewalks. Over the past several years, the City has been working with MoDOT to design improvements providing safer travel through these intersections, creating a pedestrian friendly environment, and enhancing commercial activities.

The construction period is estimated to be twelve (12) months. The construction schedule will stagger construction hours and the closure of business entrances to ensure continued traffic flow along 350 Hwy and Raytown Road and minimize business interruption.

#### **CONSTRUCTION PHASES:**

PHASE 1 Improvements: Upon completion of Phase I, Wal-Mart Drive will be expanded to two (2) left-turn lanes on to Westbound 350 Hwy. Curbs, sidewalks, and signage will be constructed along sections of Westbound and Eastbound 350 Hwy between Raytown Road and Wal-Mart Drive. Improvements will also be constructed at the intersection of 75<sup>th</sup> Street and Westbound 350 Hwy. Times of Construction and Traffic Impact: Westbound 350 Hwy will have single lane closures between 9:00 am to 4:00 pm. Eastbound 350 Hwy will have channelizers and pavement edge treatment modifying traffic between 8:30am to 3:30 pm. 75<sup>th</sup> Street will maintain 2-way-2 lane traffic.

PHASE 2 Improvements: Completion of Phase 2 will result in Raytown Road having two (2) left-turn lanes on southbound Raytown Road to Eastbound 350 Hwy. The median on Raytown Road between Westbound and Eastbound 350 Hwy will be expanded to permanently remove left-turn cut through across Raytown Road to 75<sup>th</sup> Street. The 75<sup>th</sup> Street exit off Eastbound 350 Hwy will also be eliminated in Phase 2. New curbs, as well as traffic pattern striping and signals, will be constructed on Raytown Road.

Times of Construction and Traffic Impact: Raytown Road between Westbound and Eastbound 350 Hwy will have single lane clo-


sure between **9:00 am and 4:00 pm**. Eastbound 350 Hwy will have single lane closures, as well as channelizers and pavement edge treatment when required, between **8:30am to 3:30 pm**.

**PHASE 3 Improvements:** The completed improvements will include the expansion of the bike and walking trail and sidewalk along the south side of Eastbound 350 Hwy. New traffic signal equipment and pedestrian signals will be installed at the intersections of Raytown Road and Westbound/Eastbound 350 Hwy. Additionally, the outer access road at the southwest corner of Eastbound 350 Hwy and Raytown Road will be converted to a pedestrian trail only. Raytown Road will be resurfaced between Westbound/Eastbound 350 Hwy and the median will be reconstructed on Raytown Road south of Eastbound 350 Hwy.

Times of Construction and Traffic Impact: Off-peak lane closures and channelizers will be utilized during this phase.

Terms of the construction contract include construction delays due to winter weather, thus construction in December, January and February will be limited for lengths of times. The construction plans do not anticipate at any time closing all access drives to any Raytown businesses within the construction zone. Please come out and support the Raytown businesses during the various construction phases!

# Navigating the Road to Recovery

#### Jackson County Updated Mask Order & Employee Information (08/21/2020)

The Jackson County Health Department amended the mask order to reflect changes regarding persons with exemptions. The amended order goes into effect today, August 21. The order states that businesses may allow entry and serve customers with exemptions. Exemptions include:

- Those who are deaf or hard of hearing
- Children younger than five years old; and
- O Children who are younger than two years old should never wear face coverings due to the risk of suffocation.
- O Children who are two, three, or four years old, with the assistance and close supervision of an adult, are strongly recommended to wear a face covering at all times in settings, like grocery stores or pharmacies, where it is likely that a distance of at least six feet cannot be maintained from non-household members and vulnerable people must go.
- O Persons with a medical condition, mental health condition, or disability that prevents wearing a face covering. This includes, but is not limited to, persons with a medical condition for whom wearing a face covering could obstruct breathing or who are unconscious, incapacitated, or otherwise unable to remove a face covering without assistance.

Due to this change in the mask order, we've updated our <u>blog</u> regarding how businesses should handle the mask order.

If a customer enters your business without a mask, you can ask them:

- Is (not wearing a mask) an accommodation?
- Are you not wearing a mask due to a disability or valid medical exemption?

If the answer is affirmative, the customer may enter. If their answer is negative, the business may provide an accommodation or they must refuse service. Your employees MAY NOT inquire as to the nature of the person's disability, request documentation of a medical condition or disability, or require that a person state their disability.

The mask order will still be enforced in Eastern Jackson County. **The standard of a businesses' compliance is whether they are actively checking with customers who come in without a mask.** The business will not be penalized for letting customers with exemptions in without a mask as long as employees are actively checking that they have an exemption.

#### **Employees Experiencing COVID-19**

It is no longer the requirement, nor recommended, that employees receive two negative COVID-19 tests before returning to work. Determining when an employee can return to work should follow the CDC's symptom-based strategy:

- At least 10 days\* have passed since symptoms first appeared and
- At least 24 hours have gone by without a fever and without the use of fever-reducing medication and
- Symptoms have improved

If the employee had no symptoms:

At least 10 days have passed since the date of the first positive RT-PCR test for SARS-CoV-2 RNA
